#### **NEW BUSINESS**

Resident Bill Davidson raised a concern regarding the excessive speed which motor vehicles travel along Collins Road making it unsafe for pedestrians walking on the side of the road. Commissioner Lewis Benedict mentioned that this is also a concern which the Village Commission has discussed and has planned for a sidewalk on Collins Road from Starrs Point Road to Steepleview Drive. This project should be starting in the Spring of 2022. It was also mentioned by another resident that there are new speed signs along Collins Road.

  - A call for nominations was made by Chairperson Lewis Benedict
  - After the call for nominations was made three times and no other nominations were received Kim Cogswell was declared elected to serve a two-and-a-halfyear term as Commissioner.
- A call for nominations for term retiring Commissioner Ernie Hovell was asked if he would consider running for a the two-and-a-half-year term remaining and let his name stand for nominations - Ernie agreed to let his name stand for nominations.
  - A call for nominations was made by Chairperson Lewis Benedict
  - After the call for nominations was made three times and no other nominations were received Ernie Hovell was declared elected to serve a two-and-a-halfyear term as Commissioner.

It was moved by Geoff Muttart and seconded by Kim Cogswell that the ballots are destroyed. MOTION CARRIED. (Ballots were destroyed after being retained for prescribed period).

There being no further business to come before the meeting it was moved by Wayne Blenkhorn that the meeting be adjourned. Meeting adjourned at 8:10 pm.
